NEW FEATURES

NEW FEATURES THIS RELEASE

- Online Payment Implement Stripe as a payment processor
- In certain instances when they are a lot of facets, color by results in Undefined Hex
- Contract Update search facet index to display the related Attachment Categories from the linked ABI records
- o Update map boundary layers on map move
- o Add company specific banner page to Alden One
- Default to a (United States) state when creating a conversation when no assets are selected
- o (Conversation Assets) User can't tell if the Line Editor spans pages
- Increase MaterialType length to 50 on the poleuniv record
- As a user, I want to know what type of asset I'm adding to a conversation when the dialog is open
- Conversation Assets Allow mappable assets to be displayed with shapes and colors based upon attributes.
- As a user, I want to be able to close all open tabs in Alden One
- Display selected TASKS/unconfigured asset in the card tray and create a fallback default to show unconfigured assets in card tray

BUG FIXES

BUG FIXED THIS RELEASE

- On a conversation, the Header has locks on all fields on the header for read-only user EXCEPT the description
- On a conversation, the contact suggestion drop-down re-displays when user reopens assign dialog from search
- ✓ In the "sort by" menu for photos, "newest" appears twice
- ✓ On a contract, the loading circles for History section are missing
- In Role Management, the role share/userrole dialog can be dismissed by clicking outside the dialog
- ✓ On a contract, a user is unable to make changes to contracts because the Rate Increase of % or \$ is required even when no Fee is provided
- "Request Data Access" conversation type opens to a blank screen instead of the header
- Account Billing Info Changed column order isn't saved correctly when returning to the tab
- Account Billing Info Clearing filter from 2nd filtered column does not actually clear the filter
- Poles will not display on map if pole is not the first entity listed on the conversation
- Alden One (conversation) Show/Hide Columns icons are different for pole attachments

PLANNED FOR UPCOMING RELEASE(S)

- Ameren Auto-Generate ANNUAL BILLING Invoice based on Contract/Account (manual trigger)
- For the reference data grid:
 - Add column reordering
 - Add grid filtering
 - Add grid sorting
 - Remember column state and filter when changing tabs
 - Provide ability to soft delete a reference data item with audit trail
- Provide ability to deactivate (soft delete) a reference data item (lookup)
- o Implement profile interfaces for AldenOne users to persist any user settings
- Include the asset type "Streetlights" on conversations
- o Include the asset type "Utility Poles" on conversations
- Research and implement performance improvements for changing tabs within Alden One
- o Add multi factor authentication to Alden One
- o Add Is In List (by a comma-separated list) to the search control
- Add Configuration of Permissions to the Admin Tool
