# NEW FEATURES

- Cell Structures - New Type of Asset To Be Managed in Alden One.
- Cell Structure Attachments - New Type of Sub-Asset To Be Managed in Alden One as a Child of Cell Structures.
- Make the Entry of a Custom Number of Days for Sharing a Role More Intuitive.
- Add Folder Structure to the Documents Tab on Contracts.
- Allow Users to Click Text or Blank Space in Menu Items to Select the Item.
- Apply Role to "DeleteAnyAddedDocuments" to Documents on Assets.
- Company Administrators Could Perform Functions in Manage User Screen that Should Only Be Performed by Enterprise Administrators.
- Enhance Contract Notes to Work Like Other Asset Notes.
- Direct Users to New Alden One Pro Webpage for More Alden One Information.
- Write History Records when Managing Notes, Documents, and Photos on Assets.
- Improve Conversation History Tab to Avoid Overlapping Text for Long Event Descriptions.
- Add Visual Indicator When Notes are Filtered or Sorted.

# BUG FIXES

## BUGS FIXED THIS RELEASE

- ✓ Screen Did Not Refresh Correctly After Error Displayed Indicating Conversation Not Found or Accessible.
- ✓ Users with Apostrophe in Their Email Address Received Error When a Conversation Search Was Performed.
- ✓ DateTime Fields on Assets and Sub-Assets Displayed Incorrect Values if Entered in One Timezone and Viewed in Another.
- ✓ Users Were Unable to Search For Dates With Slashes Using the Quick Search Option in Notes and Detailed History Tabs.
- ✓ DateTime Overlapped with Action Buttons on Documents Tab.
- ✓ Error Received When Searching for Conversations Using Specific Note Text.
- ✓ Map View Label Options Unexpectedly Switched to "Hide Labels" on Search Map and Conversation Map.
- ✓ Read-Only Conversation Fields Were Sometimes Editable.
- ✓ Values in the Pole Usage, Date Placed, and County Fields Were Not Always Visible After Adding a Pole to a Conversation.
- ✓ Deleted Assets Continued to be Displayed Occasionally in Search Results and Caused Error When User Attempted to Open Them.

# BUG FIXES (CONT.)

## BUGS FIXED THIS RELEASE

- ✓ Bottom of Text Was Cut Off in the Conversation Type Field on the Create A New Conversation Dialog.
- ✓ Read-Only Text Fields Did Not Display at the Field's Original Size.
- ✓ Accounting Module Menu Items Occasionally Show Subitems Out of Order.
- ✓ Display Message to User When Switching Tabs in a Contract if There are Unsaved Changes.
- ✓ Changes to Contract Values Occasionally Failed to Properly Update in Search Results.
